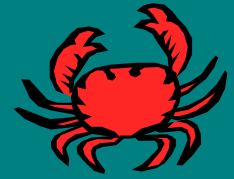

INHALANT ABUSE IN ADOLESCENTS *Preventing, Recognizing, Intervening*

Inhalants are common products whose vapors, fumes or gases are breathed (sniffed or huffed) to obtain a high. Inhalant use is a problem in Virginia. Young people use inhalants because they are legal products, easy to get and easy to use. Most adults are unaware of inhalant abuse, so they are not talking to youth about its danger or monitoring use of abuseable products. Yet inhalants are among the most deadly of substances, with the potential to cause death during first or subsequent use, as well as significant damage to the brain and body. In addition, because inhalants cannot be detected by drug screens, inhalant use is common among court-involved children. This workshop will provide participants with information about products that can be abused, how they are abused, signs of abuse, effects of abuse, and what to do if you find someone abusing. It will also address education, prevention and treatment approaches and challenges.
