**A. CRITERIA FOR TRANSITIONAL SERVICES REFERRALS**

**B. PURCHASE OF SERVICES:**

Parole officers are responsible for vendor selection based on the list of approved vendors and services identified in the Community-based Transitional Services Vendor Directory. The Parole Officer shall:

1. Determine the services that are to be purchased.
2. Determine if an approved vendor is available who can meet the identified needs of the parolee and provide the services.
3. Contact the selected vendor to discuss their ability to provide the services.
4. Provide background information on referred youth to the provider.

**C. REFERRAL PROCEDURES**

1. Parole Officer shall prepare and forward a referral packet to the Department of Juvenile Justice's Transitional Services Specialist.
2. The referral packet shall be sent five (5) days prior to the date services are to start in order to allow time for review, funding approval, entering and approval of purchase order through eVA, and receipt of purchase order by vendor prior to the requested start date.
3. The referral packet shall include a:
  - a. Completed referral form,
  - b. the completed and detailed rationale,
  - c. parole service plan and
  - d. Purchase of Service Requisition.
  - e. Referrals for surveillance and electronic monitoring need only to include a referral form and a requisition. Requests must be sent three (3) days prior to the start date.
4. Upon approval of the referral by the Transitional Services Specialist, the requisition will be entered into the Commonwealth of Virginia's eVA Purchasing System.
5. Upon approval of the requisition through the proper channel, a purchase order will be generated and forwarded to the court service unit and the vendor. A copy of the purchase order may also be sent electronically via the eVA Purchasing System to the vendor if vendor is registered to receive purchase order through the electronic system.

**D. REQUEST FOR EXTENSIONS**

1. Parole officers shall submit requests for extensions for services to the Transitional Services Specialist at least ten (10) work days prior to the scheduled termination date.

2. Extension requests must include:
  - a. A completed Purchase Order Change form,
  - b. the completed and detailed rationale, and
  - c. an updated parole service plan.
3. Progress reports from the vendor are required in order to approve the extension. Extensions will not be approved until progress reports for each month of service have been received by the Transitional Services Specialist.

**E. BILLING PROCEDURES**

1. The parole officer shall review the monthly invoices and insure that the invoice is correct based on the purchase order.
2. The Court Service Unit Director or designee shall approve monthly invoices after review by the parole officer.
3. The designated person at the Court Service Unit shall forward the approved original invoice, a receiving report, and a copy of the purchase order to:  
DJJ Accounts Payable,  
P. O. Box 1110,  
Richmond, VA 23218-1110.

**F. REPORTING REQUIREMENTS**

1. Parole officers shall notify the Transitional Services Specialist of the termination date within 2 working days by e-mail or telephone.
2. The parole officer shall complete and forward a copy of the termination report to the Transitional Services Specialist within five (5) working days of the termination.

**G. MONITORING SERVICE PROVISION:**

Monitoring of service provision is a joint responsibility of the parole officer and the Transitional Services Specialist. The parole officer is the primary monitor of the individual services provided to each parolee. The Transitional Services Specialist is the monitor for overall contract compliance, mediating any conflicts, and determining termination of the use of a contracted vendor.

1. The parole officer is responsible for verifying service provision through regular contacts with the service provider, parolee and family.
2. Parole officers should have weekly verbal or e-mail contacts with the vendors to insure service provision.
3. Parole officers should have monthly meetings with the vendor and the parolee and families to insure service provision.
4. Parole officers should at a minimum request monthly contact logs from the vendors and review logs and compare to the invoices received.

5. Parole officers shall complete the termination report within 5 days of termination that provides feedback to the Transitional Services Specialist on the overall satisfaction with the vendor.
6. Parole officers, supervisors and or Court Service Unit Directors should make every attempt to resolve issues and conflicts with regard to service provision or invoicing at the local level.
7. Supervisors should notify the Transitional Services Specialist of ongoing issues with vendors and of attempts to resolve problems. Any written correspondence to the vendor shall be copied to the Transitional Services Specialist.
8. The Transitional Services Specialist shall intervene as necessary when issues can not be resolved between the CSU and the vendor.
9. The Transitional Services Specialist is responsible for any final decision making regarding terminating a vendor from continued use by the CSU.
10. The Transitional Services Specialist is responsible for scheduling regular monitoring visits with vendors to insure overall contract compliance and review the overall quality of services. Parole officers will be given the opportunity of assisting with the monitoring visits. The Transitional Services Specialist will notify selected parole officers when doing an on site monitoring visit to invite their participation in the monitoring visit.
11. Prior to an on-site monitoring visit, the Transitional Services Specialist will forward a vendor satisfaction survey to parole officers using the vendor to be monitored. The survey results will be used during the monitoring visit with the vendor to provide feedback from the CSU on the vendor's quality of services.

## ATTACHMENT C

### RESIDENTIAL PLACEMENT PROCEDURES

Effective July 1, 2008

#### I. PLACEMENT GUIDELINES:

The Department has limited funding to enhance bed capacity for transitional placements for male and female offenders leaving the Juvenile Correctional Centers. Residential placements can be made with the approved vendors (see following pages) by following procedures as outlined below.

Juvenile offenders referred must be 16 - 20.5 years of age. Placements will initially be approved for four (4) months. Extensions for two additional months can be requested. The extension must be received, reviewed and approved prior to the end of the initial four month stay. The maximum length of stay is six (6) months.

Referrals for male parolees must indicate in the rationale for placement that there is currently not bed space available in the state-operated halfway houses, the parolee was not accepted, or placement with the selected vendor can better meet the needs of the parolee. Referrals must also indicate placement plans for the parolee following discharge from the residential facility.

Referrals for female parolees will also follow the same procedures. While there are no state-operated halfway houses for females, you would also submit a halfway house rationale that will address the need for placement, what will be the goals and objectives of placement, and the placement plans upon completion of a private placement.

#### II. REFERRAL AND APPROVAL PROCEDURES:

##### A. Vendor Selection and Funding Request:

The parole officer shall:

1. Determine if an approved vendor can meet the needs of the parolee and has bed space available.
2. Forward background information on the referred youth to the vendor to allow the vendor to make a decision regarding acceptance.
3. Prepare and forward a referral packet to Andrea McMahon, Transitional Services Specialist, at least sixty days (60) days prior to the anticipated release date. The referral packet must include:
  - a. The Community Based Transitional Services Referral Check List. (294 check list)
  - b. The Rationale of Halfway House Placement. The rationale must include a statement as to why the parolee is unable to be placed in a state-operated halfway house or in the Transitional Living Program if the request is for a male parolee.

- c. Confirmation of acceptance from the vendor as soon as it is available.

### B. Extension of Services

1. Forward a request for an extension of services at least ten (10) work days prior to the end of the initial four months by completing a new Rational for Placement that indicates the need for continued placement and the goals and objectives to be accomplished with an additional two months.
2. Monthly progress reports from the vendor will also be reviewed to consider an extension for 2 months.

### C. Funding Approval:

The Transitional Services Specialist shall:

1. Review the referral packet and approve funding for the placement. Funding will be approved for four months. Extensions for services may be approved for an additional two months.
2. Enter the purchasing information into eVA.
3. Forward the approved purchase order to the vendor.

### D. Billing Procedures:

1. Bills will be forwarded by the vendor to the Transitional Services Specialist.
2. The Transitional Services Specialist will verify days of services, approve and forward to Accounts Payable.

### E. Reporting Requirements:

1. The parole officer will complete and forward Community Based Transitional Services Termination Report to the Transitional Services Specialist within three (3) working days of the youth's discharge.
