2005 VJJA Fall Institute "One Size Doesn't Fit All"
Virginia Beach, VA – November 2, 3 & 4

Planned around the theme "**One Size Doesn't Fit All**", the **2005 Fall Institute** will officially kick off on the afternoon of Wednesday, November 2, 2005. Participants will hear from **nationally-recognized speakers** in the areas of structured-decision making, risk-based supervision, gender-responsive programming, mental health, adolescent brain development, detention reform and evidence-based practices. **Featured speakers and conference faculty** include **Mr. Robert Bermingham, Jr.**, President, Virginia Juvenile Justice Association; **Mr. Barry Green**, Director, Virginia Department of Juvenile Justice; **Dr. James C. "Buddy" Howell**, University of South Carolina and the Institute for Intergovernmental Research, Tallahassee, FL; **Mr. David Gamble**, Director, The Juvenile Sanctions Center, National Council of Juvenile and Family Court Judges (NCJFCJ), Reno, NV; **Dr. Lawanda Ravoira**, Pace Center for Girls, Jacksonville, FL; **Dr. Gail Wasserman**, The Center for the Promotion of Mental Health in Juvenile Justice, Columbia University; **Dr. Faye Taxman**, Virginia Commonwealth University; **Dr. Jeffrey Aaron**, Commonwealth Center for Children & Adolescents and the Institute for Law, Psychiatry & Public Policy at the University of Virginia; and **Judge Frank Orlando, J.D. (ret.)**, Annie E Casey Foundation and the Center for the Study of Youth Policy, Nova Southeastern University.

In addition to formal learning opportunities, the Institute will incorporate off-site tours to local residential facilities and on-site exhibits. At least 30 Exhibitors, representing national, state and local programs, services and agencies are expected. The Institute will also offer occasions for networking and socialization. Wednesday, November 3rd, will mark the association's **2nd Annual Leadership Mixer**. Begun in 2004, the Leadership Mixer provides a forum for conference attendees to meet the members of the VJJA's Board of Directors. All attendees are invited to learn more about leadership opportunities at the state and local level. Later that same evening, there will be a **Dance / Social** where attendees will be treated to music provided by former VJJA President turn DJ, Lewis Wright. Networking opportunities continue on Thursday evening with Bob Bermingham hosting the annual **President's Reception**. Always a popular event, the President's Reception provides an opportunity for "shop talk" over hors d'oeuvres and cocktails.

Day two of the conference will include the association's Annual Business Meeting, Luncheon and Awards ceremony. Meritorious **awards** will be awarded in the areas of Administration, Court Services, Residential and Community Service. Two professional development **scholarships** will be awarded.
